Description

A549-Luc2 is a luciferase expressing cell line was derived from parental line CCL-185 by transduction with lentiviral vector encoding firefly luciferase gene (luc2) under control of EF-1 alpha promoter. This cell line was established through single cell cloning, and the cells constitutively express high levels of enzymatically active luciferase protein, which can be detected via in vitro and in vivo bioluminescence assays. This cell line was developed by ATCC and can be used in the drug development research.

Upon thawing, the conversion of the liquid nitrogen back to its gas phase may result in the vial exploding or blowing off its cap with dangerous force creating flying debris. Unless necessary, ATCC recommends that these cultures be stored in the vapor phase of liquid nitrogen rather than submersed in liquid nitrogen.

Handling Procedures



Unpacking and storage instructions:

- 1. Check all containers for leakage or breakage.
- 2. Remove the frozen cells from the dry ice packaging and immediately place the cells at a temperature below -130°C, preferably in liquid nitrogen vapor, until ready for use.

Complete medium: The base medium for this cell line is F-12K Medium (ATCC 30-2004). To make the complete growth medium, add the following components to the base medium:

- Fetal bovine serum (FBS; ATCC 30-2020) to a final concentration of 10%
- Blasticidin to a final concentration of 8 μg/mL

Handling Procedure:

To ensure the highest level of viability, thaw the vial and initiate the culture as soon as possible upon receipt. If upon arrival, continued storage of the frozen culture is necessary, it should be stored in liquid nitrogen vapor phase and not at -70°C. Storage at -70°C will result in loss of viability.

- 1. Thaw the vial by gentle agitation in a 37°C water bath. To reduce the possibility of contamination, keep the O-ring and cap out of the water. Thawing should be rapid (approximately 2 minutes).
- 2. Remove the vial from the water bath as soon as the contents are thawed, and decontaminate by dipping in or spraying with 70% ethanol. All of the operations from this point on should be carried out under strict aseptic conditions.
- 3. Transfer the vial contents to a centrifuge tube containing 9.0 mL complete culture medium. and spin at approximately $125 \times q$ for 5 to 7 minutes.
- 4. Resuspend cell pellet with the recommended complete medium (see the specific batch information for the culture recommended dilution ratio). It is important to avoid excessive alkalinity of the medium during recovery of the cells. It is suggested that, prior to the addition of the vial contents, the culture vessel containing the complete growth medium be placed into the incubator for at least 15 minutes to allow the medium to reach its normal pH (7.0 to 7.6). pH (7.0 to 7.6).
- 5. Incubate the culture at 37° C in a suitable incubator. A 5% CO₂ in air atmosphere is recommended if using the medium described on this product sheet.

Subculturing procedure:

Volumes used in this protocol are for 75 cm² flask; proportionally reduce or increase amount of dissociation medium for culture vessels of other sizes. Corning[®] T-75 flasks (catalog #430641) are recommended for subculturing this product.

- 1. Remove and discard culture medium.
- 2. Briefly rinse the cell layer with 0.25% (w/v) Trypsin- 0.53 mM EDTA solution to remove all traces of serum that contains trypsin inhibitor.
- 3. Add 2.0 to 3.0 mL of Trypsin-EDTA solution to flask and observe cells under an inverted microscope until cell layer is dispersed (usually within 5 to 15 minutes).
 - Note: To avoid clumping do not agitate the cells by hitting or shaking the flask while waiting for the cells to detach. Cells that are difficult to detach may be placed at 37°C to facilitate dispersal.
- 4. Add 6.0 to 8.0 mL of complete growth medium and aspirate cells by gently pipetting.
- 5. Add appropriate aliquots of the cell suspension to new culture vessels. Cultures can be established between 2 x 10^3 and 1 x 10^4 viable cells/cm². Do not exceed 7 x 10^4 cells/cm².
- 6. Incubate cultures at 37°C.

Interval: Maintain cultures at a cell concentration between 6 X 10³ and 6 X 10⁴ cell/cm².

Subcultivation Ratio: A subcultivation ratio of 1:3 to 1:8 is recommended

Medium Renewal: 2 to 3 times per week

Reagents for cryopreservation: Complete growth medium supplemented with 5%

(v/v) DMSO (ATCC 4-X)
