### Description

This product is a whole-genome sequenced preparation of Severe acute respiratory syndrome-related coronavirus 2 (SARS-CoV-2) strain 2019-n-CoV/USA-WA1/2020 that has been inactivated by heating. This strain was originally isolated from a human case in Washington state and was deposited by the Centers for Disease Control and Prevention. This product is intended for use in molecular assays or as a process control (eg, viral RNA extraction through gPCR amplification process), and it can also be used to make a dilution series to estimate level of detection.

This product is a preparation of Severe acute respiratory syndrome-related coronavirus 2 (SARS-CoV-2) strain 2019-nCoV/USA-WA1/2020 that has been inactivated by heating to 65°C for 30 minutes and is therefore unable to replicate.

Each vial contains approximately 0.25 mL of heat-inactivated, clarified cell lysate and supernatant from Vero E6 cells infected with SARS-CoV-2 strain 2019-nCoV/USA-WA1/2020. The vial should be centrifuged prior to opening.

The long-term stability of this preparation is not known at this time. It is recommended that users confirm the activity of the product if not used within three months of receipt.
