The quantitative format allows for the generation of a standard curve for quantitative PCR (qPCR) to determine viral load. Handling Procedures

- 1. Thaw the vial at room temperature and immediately place on ice. Avoid exposing the synthetic RNA to repeated freeze-thaw cycles as it may result in degradation of the RNA and variation in copy number.
- 2. Gently mix the sample to ensure an even distribution of material.
- 3. Briefly centrifuge the tube before opening to ensure all liquid is at the bottom.

Notes

RNA is easily degraded. Take extra precautions against contamination by using new

gloves and clean lab coats when working with RNA. Use only RNase-free lab materials when handling this product. Vortexing can damage the synthetic RNA. Gentle pipetting is highly recommended. Aliquotting is highly recommended to avoid multiple freeze-thaws, which can damage the synthetic RNA.
